OLD BUSINESS

Habitat Update: Beth Weaver of Habitat for Humanity updated the board on the 426 N. Grant Street property. She stated there were two families interested in the property. Weaver offered to purchase the land for \$10,000. The two entities attorneys will communicate to determine the next steps in the transfer process. The Wayne County Auditor appraised the property for \$16,880. Habitat will send WCLRC a letter of intent to purchase.

Smail: Deb Cline of the prosecutor's office sent a list of three parcels to be voted on for acceptance, 27-01134.001, appraised at \$54,900; 10-00647.006, appraised at \$12,000; and 39-00448.00, appraised at \$10,380. The appraised value is from the Wayne County Auditor's website. Board agreed to accept all three properties if they become available. No vote necessary.

Smail: Meng/Gearhart property, 21-00189.000, is landlocked. The property has an appraisal value of \$4,200. A letter was sent to Mr. Dan Flory to determine his interest in purchasing the parcel. WCLRC was contacted by the property owner, Meng, about this property.

OTHER BUSINESS

Smail: The parcel at 609 E. Henry Street, 65-01385.000, was transferred to the WCLRC from the estate of Susan Brown on 11/15/2022.

Smail: Orrville demo project begins on Nov 28. Starcher will get exterior photos on Monday at 142 Depot.

Smail: Tim Boggs is expected to begin demolition in early December for the West Salem property at 250 Greely Street.
